The purpose of this modification is to provide incremental funding in the amount of \$20,439.00 thereby increasing the total obligations from \$824,838.00 to \$845,277.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$845,277.00 of which \$787,772.00 represents the estimated reimbursable costs, and the amount of \$57,505.00 represents the fixed fee."

All other terms and conditions remain the same including the contract ceiling of \$845,277.00.
