SUBJECT: SUMMARY OF THE JANUARY 20, 2011, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On January 20, 2011, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff discussed the status of FAQ 08-0053, which deals with Kerite cable categorization. The staff stated that they were waiting to receive the final test report, and that they planned to issue it to the public by the end of February.

Licensees presented a new revision of FAQ 08-0054, which deals with compliance with NFPA 805 Chapter 4, that incorporated NRC comments. The NRC staff confirmed that technical agreement had been achieved on this FAQ, with the incorporation of previous NRC comments.

NRC staff presented an updated schedule for the review of the Oconee pilot plant's license amendment request. They noted that this update documents the issuance of the Oconee Safety Evaluation, and that this is the final update since the pilot plant review process had concluded.

Participants agreed that the next FAQ meeting would take place on February 17, 2011 via teleconferencing. A future meeting was scheduled, as a teleconference, for March 17, 2011.
