Dear Dr. Meengs:

Enclosed is Amendment No. 17 to your NRC Material License No. 21-24873-01 in accordance with your request dated December 6, 2010. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please be advised that prior to performing positron emission tomography (PET) imaging, you will need to amend your NRC license to include shielding information of your facility and provide a copy of your shielding calculations that shows compliance 10 CFR Part 20, Radiation levels in unrestricted areas.

Please note that included with amendment No. 17 is a corrected copy of amendment No. 16. Amendment No. 16 was originally issued as amendment No. 15, however, it should have been issued as amendment No. 16. Sorry for any inconvenience this may have caused.

Based on the information provided in your letter dated December 6, 2010, the NRC consents to the change of control of your NRC license. It also appears that no changes are needed to your NRC license due to the change of control.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
