- (2) Consider new rules and programs to further the policies described in (a)(1), reevaluate existing programs to prohibit text messaging while driving, and conduct education, awareness, and other outreach programs for employees about the safety risks associated with text messaging while driving. These initiatives should encourage voluntary compliance with the text messaging policy while off duty.
 - (b) For purposes of complying with the Executive Order:
- (1) "Texting" or "Text Messaging" means reading from or entering data into any handheld or other electronic device, including for the purpose of SMS texting, e-mailing, instant messaging, obtaining navigational information, or engaging in any other form of electronic data retrieval or electronic data communication.
- (2) "Driving" means operating a motor vehicle on an active roadway with the motor running, including while temporarily stationary because of traffic, a traffic light or stop sign, or otherwise. It does not include operating a motor vehicle with or without the motor running when one has pulled over to the side of, or off, an active roadway and has halted in a location where one can safely remain stationary.
- (c) The Contractor or Recipient shall encourage its subcontractor(s) or sub-recipient(s) to adopt and enforce the policies and initiatives described in this clause.

STATEMENT OF WORK "FUEL CYCLE INFORMATION EXCHANGE 2011"

A. BACKGROUND

The Office of Nuclear Material Safety and Safeguards (NMSS), Division of Fuel Cycle Safety and Safeguards (FCSS) conducts an annual public meeting on general issues of relevance to the regulation of the Fuel Cycle industry entitled the "Fuel Cycle Information Exchange" or FCIX. The size of the audience has steadily grown each year, with over 240 registered attendees in 2010. FCSS is interested in securing a conference facility for hosting the event in 2011.

B. OBJECTIVE

The objective of this order is to lease a conference room, complete with chairs, tables and audio/video equipment for hosting the NRC FCIX 2011 Conference.

C. PROPOSED DATES

The conference duration is two (2) days. The proposed date for the FCIX 2011 conference is June 7-8, 2011. The schedule would be to commence at 8:00 a.m. and end at 5:00 p.m. each day.

Any services (i.e. conference room space and/or use of equipment) provided by the contractor, prior to receiving authorization from the Contracting Officer is done so at the contractor's sole risk.

D. NUMBER OF ATTENDEES

The maximum number of attendees at the FCIX 2011 is anticipated to be 250 people.

E. ACCOMMODATIONS

The NRC is not making any guarantees on the number of hotel rooms that will be booked by conference attendees and the NRC is not responsible in any way for charges associated with hotel accommodations.

F. CONFERENCE FACILITIES

The conference facility for FCIX 2011 shall accommodate up to 250 people in a single room, with 10 seats maximum between isles. The room shall be arranged for theater-style seating, with a low stage facing multiple rows of seats, with aisle ways as needed. The stage shall include a podium and several tables (with skirting), for seating up to 6 individuals on a panel with three (3) microphones. Refer to the attached room arrangements sketch for additional requirements.

A registration area with 2 tables (skirted) and 4 chairs shall be set up outside the meeting room.

The FCIX does not include lunch. Attendees will be responsible for their own lunch. Food service is not included in this contract.

G. FACILITY LOCATION

To ensure efficiency of the Government and minimize the travel time, the conference facility shall be located close to the NRC Headquarters building in Rockville, MD. Specifically, the facility shall be located along the red line of the Metro rail system, within a 10 minute train ride of the NRC headquarters facility at White Flint, or along Rockville Pike, within a 15 minute ride by shuttle bus from the NRC headquarters buildings at White Flint. If the location of the facility is greater than three blocks from a Metro Station, then shuttle service shall be provided and the cost of such service shall be included. The number and size of shuttle buses shall be sufficient to ensure 100 attendees are transported from the nearest metro station to the facility within 1 hour, especially in the morning.

H. COMMUNICATIONS AND OTHER EQUIPMENT

The NRC Project Officer (i.e., FCIX Coordinator) will provide an NRC-owned laptop with the presentations pre-loaded in Microsoft PowerPoint, or equivalent software. FCIX 2011 will <u>not</u> be webcast or video-recorded; therefore no specialty audio-video or telephone equipment is anticipated to be needed. The contractor shall provide and set-up the following equipment for each day of the conference:

- LCD projector(s), compatible with a laptop PC interface with an USB port for input
- Projection screen(s) of sufficient size to be viewed with ease at the back of the room
- Podium
- 1 microphone mounted on the podium
- 3 tabletop microphones at head table (push-to-talk preferred)
- 1 standing microphone in aisle for audience Q&A
- 1 Splitter for sending the signal from the laptop to 2 LCD projectors, if proposing 2 screens, depending on the room layout.
- Public address system w/speakers of sufficient volume to be heard from any point in the conference room.


