Entergy has revised the James A. FitzPatrick Nuclear Power Plant Physical Security Plan (PSP) in accordance with 10 CFR 50.54(p)(2). This revision 1) updates descriptions of the facility, including drawings and figures, to reflect the changes made to meet the requirements of the revised 10 CFR 73.55; 2) removes schedular exemptions, to the implementation of specific new requirements of 10 CFR 73.55, which were approved by the NRC on March 26, 2010; and 3) incorporates minor editorial changes. The descriptions are revised and the exemptions are removed based on achieving full compliance with the requirements of 10 CFR 73.55.

In accordance with 10 CFR 50.4(b)(4), the revised PSP is enclosed with this letter (Attachment 1).
