Please amend our Radioactive Materials License # 07-27897-01 Cardiology Consultants, P.A., Cardiac Diagnostic Center located at Pike Creek Sports Medicine Building, 3105 Limestone Road, Suite 201 Wilmington, Delaware 19808-2151. Please break down the license in the following manner. The Limestone Road, Silverside Road and Middletown sites (A,B,D) will be transferred to Christiana Care Health Services; the Forrest Avenue and North DuPont Highway sites (C,G) will be transferred to Bayhealth Medical Center; and the King's Highway and Atlantic Avenue sites (E,F) will remain on the current license.
