

The purpose of this modification is to increase the amount obligated by \$30,000.00 from \$406,157.00 to \$436,157.00. Accordingly, the contract is modified as follows:

Paragraph 3, page 2 of 2 under the Basic Task Order 38, is hereby deleted in its entirety and replaced with the following:

"The amount obligated by the Government in respect to this task order is \$436,157.00 of which \$415,388.00 represents the reimbursable costs, and the amount of \$20,769.00 represents the fixed fee.
