The purpose of this modification is to provide incremental funding in the amount of \$25,000.00 thereby increasing the total obligations from \$253,691.00 to \$278,691.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$278,691.00 of which \$261,608.00 represents the estimated reimbursable costs, and the amount of \$17,083.00 represents the fixed fee."

All other terms and conditions of the subject task order remain unchanged including the ceiling amount of \$298,767.00.


