SUBJECT: ANNUAL ASSESSMENT LETTER FOR PALISADES NUCLEAR PLANT

Dear Mr. Kirwin:

On February 17, 2011, the NRC completed its end-of-cycle performance review of Palisades Nuclear Plant. The NRC reviewed the most recent quarterly performance indicators (PIs) in addition to inspection results and enforcement actions from January 1, 2010, through December 31, 2010. This letter informs you of the NRC's assessment of your facility during this period and its plans for future inspections at your facility. This performance review and enclosed inspection plan do not include security information. A separate letter will include the NRC's assessment of your performance in the Security Cornerstone and its security-related inspection plan.

The NRC determined that overall, Palisades Nuclear Plant operated in a manner that preserved public health and safety and met all cornerstone objectives. Performance during the most recent quarter was within the Licensee Response Column of the NRC's Reactor Oversight Process (ROP) Action Matrix because all inspection findings had very low (i.e., green) safety significance, and all Pls indicated that your performance was within the nominal, expected range (i.e., green). Plant performance for the first, second, and third quarters of 2010 was within the Regulatory Response column of the NRC's Action Matrix based on one inspection finding in the Initiating Events Cornerstone, from the fourth quarter of 2009, which involved degradation of the neutron absorption capability of the Spent Fuel Pool plates. On September 17, 2010, the NRC completed a supplemental inspection (Inspection Report No. 05000255/2010009) which closed the finding and concluded that Palisades transitioned to the Licensee Response column at the end of the third quarter. Therefore, the NRC plans to conduct ROP baseline inspections at your facility.

The enclosed inspection plan lists the inspections scheduled through June 30, 2012. Routine inspections performed by resident inspectors are not included in the inspection plan. The inspections listed during the last 9 months of the inspection plan are tentative and may be revised at the mid-cycle performance review. The NRC provides the inspection plan to allow for the resolution of any scheduling conflicts and personnel availability issues. The NRC will contact you as soon as possible to discuss changes to the inspection plan should circumstances warrant any changes.
