

The purpose of this modification is as follows:

- (1) Exercise Optional Task 3: Support for Licensing Proceeding and Litigation for Task 2 in the amount of \$39,795, pursuant to FAR 52.217-9, Option to Extend the Term of the Contract;
- (2) Provide incremental funding in the amount of \$10,000; and
- (3) Extend the period of performance of the task order through August 31, 2011.

Accordingly, the following change is hereby made:

1. Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraphs (a) and (c) are hereby deleted in their entirety and replaced with the following:
 - (a) The total estimated cost to the Government for full performance of this contract is **\$98,054**, of which the sum of [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represents the fixed fee.
 - (b) The amount presently obligated with respect to this order is **\$69,259**, of which the sum of [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represents the fixed fee. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contactor in excess of the obligated amount specified above is done so at the Contractor's sole risk.
2. Section 2. PERIOD OF PERFORMANCE is deleted in its entirety and replaced with the following:

The period of performance of this order shall be September 9, 2010 through August 31, 2011.
