

The purpose of this modification is to increase the amount obligated by \$45,000.00 from \$260,000.00 to \$305,000.00. Accordingly, the contract is modified as follows:

Paragraph 3, page 2 of 2 under the Basic Task Order 28, is hereby deleted in its entirety and replaced with the following:

"The amount obligated by the Government in respect to this task order is \$305,000.00 of which \$282,407.00 represents the reimbursable costs, and the amount of \$22,593.00 represents the fixed fee.
