Rescheduling of USEC Inc. Implementation of Nuclear Energy Institute 08-11 Guidance

Dear Ms. Haney:

Purpose

The purpose of this letter is to provide USEC Inc.'s (USEC) implementation plan for the Nuclear Energy Institute (NEI) guidance document, NEI 08-11, "Information Security Program Guidelines for Protection of Classified Material at Uranium Enrichment Facilities" relating to the Security Program for the American Centrifuge Plant (NR-3605-0004).

Background

USEC letter dated September 25, 2009 (Reference 1) informed the U.S. Nuclear Regulatory Commission (NRC) of the planned submittal and implementation of the NEI 08-11 guidance document for applicability to the American Centrifuge program. Specifically, implementation related to the Operations Security and Counterintelligence programs were previously scheduled within 30 days from NRC approval, and Classified Item Control and Inventory and Armed Response programs were previously scheduled within 60 days from NRC approval.

Discussion

In a letter dated February 18, 2011 (Reference 2), the NRC approved USEC's proposed changes related to incorporating the guidance of NEI 08-11. In addition, on February 4, 2011 (Reference 3), the NRC also transmitted an updated Standard Practice Procedures Plan Standard Format and Content Guide for the Protection of Classified Matter (Guide) to support USEC's activities related to transferring the American Centrifuge Lead Cascade Facility and American Centrifuge Plant Materials Licenses from USEC to American Centrifuge Operating, LLC. In order to optimize the resources involved with making the necessary changes to the Security Program and implementing procedures, USEC is rescheduling the implementation of the NEI 08-11 changes approved by the NRC. Furthermore, USEC intends to make changes to the Security Program in order to address the additional guidance on substantive and non-substantive changes identified by Reference 4.

Implementation of the NEI 08-11 and Reference 4 changes will be concurrent with implementation of the Guide-related changes supporting the transfer of material licenses to the American Centrifuge Operating, LLC.

Action

The revised schedule for implementation of the enhanced information security provisions is provided for NRC staff's information. No specific action is requested.
