By letter dated December 11, 2006 (Reference 1), the Joint Owners' Group (JOG) submitted the approved version of MPR-2524, "Joint Owners' Group (JOG) Motor Operated Valve Periodic Verification Program Summary." This version included the USNRC Final Safety Evaluation. Subsequently, in letter dated June 20, 2007(Reference 2), the JOG submitted revised pages of the MPR-2524 report to correct an error that had been discovered since the NRC Final Safety Evaluation was issued. This letter requested NRC review of these revised pages. The NRC staff completed this additional review, and by letter dated August 14, 2008 (Reference 3) provided a Draft Supplement to the Safety Evaluation. The NRC staff then, by letter dated September 18, 2008 (Reference 4), provided the Final Supplement to the Safety Evaluation.

Additional copies sent to PM DO48 NRR The PWR Owners Group (PWROG) has revised MPR-2524 to reflect the USNRC Final Supplement to the Safety Evaluation of the "Joint Owners' Group (JOG) Motor Operated Valve Periodic Verification Program Summary." - Addition of USNRC Supplemental Safety Evaluation (see Front Matter of Enclosure 1)
- Editorial changes to the order of document materials to be consistent with NRC guidelines (see Record of Revisions in Enclosure 1)
