With this letter, Mitsubishi Heavy Industries, Ltd. ("MHI") transmits to the U.S. Nuclear Regulatory Commission ("NRC") the technical report "US-APWR DCD Revision 2 RAI Tracking Report, Revision 7." This report includes a table that identifies the impact of each response to the Request for Additional Information ("RAI") relative to the Design Control Document ("DCD") of US-APWR. The report also includes the DCD markups for the RAI responses that impacted the DCD. The report is being submitted electronically in compact disc ("CD").

Currently, this report incorporates RAI responses regarding seismic analyses that were submitted by December 31, 2010, editorial changes to clarify the English language and to correct typographical errors, and engineering progress which doesn't affect the safety functions of US-APWR standard design.

This report is being submitted in two versions. One version includes certain information, designated pursuant to the Commission guidance as sensitive unclassified non-safeguards information, referred to as security-related information ("SRI"), that is to be withheld from public disclosure under 10 C.F.R. § 2.390. The information that is SRI is identified by brackets. The second version omits the SRI and is suitable for public disclosure. In the public version, the SRI is replaced by the designation "[Security-Related Information - Withheld under 10 CFR 2.390]."
