Dear Mr. Bronson:

On November 4, 2010, the NRC issued Mr. Peter Dietrich, former Site Vice President, a Final Significance Determination for a greater than green security finding (ML103080108). Our letter noted that Entergy Nuclear Northeast had taken immediate corrective actions to address any security-related vulnerability associated with the finding. Our letter also stated that any enforcement action for related violation(s) would be handled by separate correspondence at a later date.

On January 4, 2011, the NRC's Office of Investigations (OI) completed an investigation to determine whether acts associated with the finding were willful. Based upon evidence gathered during the OI investigation, the NRC concluded that there were no willful acts associated with the finding. Nonetheless, a violation of NRC requirements occurred. The Notice of Violation includes security-related, sensitive information and is not included in this letter, but is in a non-public enclosure.

The NRC has concluded that the information regarding the reason for the violation, the corrective actions taken and planned to correct the violation and prevent recurrence, and the date when full compliance was achieved is already adequately addressed on the docket in Inspection Report 05000333/2010405 and the non-public enclosures to the NRC letter dated November 4, 2010. Therefore, you are not required to respond to this letter unless the description therein does not accurately reflect your corrective actions or your position.
