Emergency Action Level Changes

REFERENCE: (a) Nuclear Energy Institute (NEI) 99-01, Revision 5, "Methodology for Development of Emergency Action Levels," dated February 2008 (ADAMS Accession No. ML080450149)

Calvert Cliffs Nuclear Power Plant requests Nuclear Regulatory Commission (NRC) approval for the adoption of revised Emergency Action Levels (EALs) for use at the Calvert Cliffs Nuclear Power Plant in accordance with 10 CFR Part 50, Appendix E, Section IV(B)(1). The revised EALs are based on Reference (a). Current Calvert Cliffs EALs are based on NEI 99-01, Revision 4.

Nuclear Regulatory Commission approval is requested by February 1, 2012, with the EAL changes being implemented within 180 days after approval. The implementation time was selected to allow operator and Emergency Response Organization familiarization.

Emergency preparedness representatives from the Maryland Department of the Environment, Maryland Department of Natural Resources, and the affected counties have reviewed and are in agreement with the proposed EAL changes.


