This e-mail confirms our discussion today concerning Entergy's March 1, 2011, request to participate in the formal consultation and conference process between NRC and NMFS pursuant to Section 7 of the Endangered Species Act, and for a 45-day extension of the consultation process. Based on our discussion, it is Entergy's understanding that the formal consultation period is being extended beyond March 16, 2011, and that Entergy will be given an opportunity to submit information during the extended consultation period. It is also our understanding that the exact duration of the extended consultation period will be communicated to us in the near future. However, in the interim, you have

confirmed that Entergy need not submit information for purposes of the consultation on March 16, 2011. As you noted, please forward this message to Drew Stuyvenberg, the NRC project environmental manager for the IPEC license renewal project. Thank you for your assistance.
