**SEVERE WEATHER RESPONSE PROCEDURES**

By letter dated February 10, 2011, Dominion Nuclear Connecticut, Inc., (DNC) and Virginia Electric and Power Company (Dominion) submitted requests for exemption from the requirements of 10 CFR 26.205(c) and (d) for meeting work hour controls during declarations of severe weather conditions involving tropical storm or hurricane force winds for Millstone Power Station Units 1, 2 and 3 and North Anna and Surry Power Stations Units 1 and 2, respectively. During a February 24, 2011 telephone conversation with the NRC Project Manager for North Anna Power Station, the NRC requested copies of the Millstone, North Anna and Surry severe weather procedures and the fleet Hurricane Response Plan (Nuclear). The requested documents are enclosed and include the following:
