

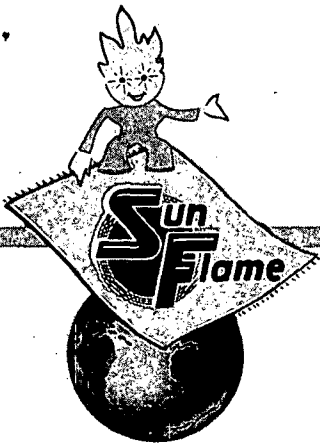

Due to the fact that we have just received the copies of the records, we are requesting an extension of the time limit mentioned in your letter, to allow us sufficient time to complete the renewal application.

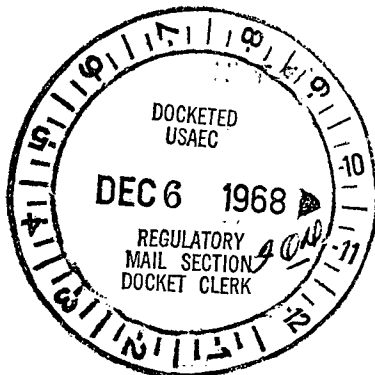
Your usual kind cooperation in this matter will be greatly appreciated.
