Gentlemen:

Pursuant to the Atomic Energy Act of 1954 and Section 40.21 of the Code of Federal Regulations, Title 10 - Atomic Energy, Chapter 1, Part 40 - Control of Source Material, you are hereby licensed to receive possession of and title to refined source material (thorium nitrate) during the term of this license, for use in the manufacture of incandescent mantles. This license also extends to your plant at Morris, Illinois.

You are further licensed to export incandescent mantles from the United States, without prior AEC authorization, to the extent that the total number of mantles to any single consignee, in any calendar month, does not exceed 100,000 units; except that exports in any quantity to the following destinations will require prior AEC approval:

- Albania
- Bulgaria
- China, including Manchuria (and excluding Taiwan (Formosa))(includes Inner Mongolia; the provinces of Tsinghai and Szechwan; Sinkiang; Tibet; the former Manchung Leased Territory, the present Port Arthur Naval Base Area and Liaoning Province)
- Communist-controlled area of Viet Nam
- Czechoslovakia
- East Germany (Soviet Zone of Germany and the Soviet Sector of Berlin)
- Estonia
- Hungary
- Latvia
- Lithuania
- North Korea
- Outer Mongolia
- Poland & Danzig
- Rumania

Exports of incandescent mantles in excess of the 100,000 units to any single consignee, in any calendar month, and the export of any other AEC controlled material, shall have prior authorization which may be applied for on Form AEC-7, in accordance with instructions on the form.

In making export shipments of incandescent mantles, you or your shipping agent should stamp each copy of the Shipper's Export Declaration as follows:
