The U.S. Nuclear Regulatory Commission (NRC) has completed the final supplemental environmental impact statement (FSEIS) for the application for combined licenses (COLs) for the Vogtle Electric Generating Plant, Units 3 and 4. A copy of the FSEIS, NUREG-1947, "Final Supplemental Environmental Impact Statement for Combined Licenses (COLs) for Vogtle Electric Generating Plant Units 3 and 4: Final Report" is included with this letter for your information. Comments received from consulting parties and members of the public on the draft SEIS were considered and responses are provided in Appendix E of the FSEIS.
