SUBJECT: SUMMARY OF MARCH 17, 2011, CLOSED MEETING WITH LUMINANT GENERATION COMPANY LLC TO DISCUSS THE GENERIC REQUEST FOR ADDITIONAL INFORMATION PERTAINING TO ITS CYBER SECURITY SUBMITTAL (TAC NOS. ME4251 AND ME4252)

On March 17, 2011, a closed meeting was held between the U.S. Nuclear Regulatory Commission (NRC), and representatives of Luminant Generation Company LLC (Luminant, the licensee), at NRC Headquarters, Two White Flint North, 11545 Rockville Pike, Rockville, Maryland. The meeting was held via a conference call.

The purpose of the meeting was to discuss the generic request for additional information (RAI) transmitted to the licensee by NRC letter dated March 2, 2011 (Agencywide Documents Access and Management system (ADAMS) Accession No. ML110560831), related to the Comanche Peak Nuclear Power Plant Cyber Security Plan (CSP) submitted by letter dated July 15, 2010 (ADAMS Accession No. ML102030124), per Title 10 of the *Code of Federal Regulations* (10 CFR), Section 73.54. The following topics were discussed:

1. Records Retention
2. Implementation Schedule
3. Scope of Systems

The licensee clarified its mutual understanding of RAI Nos. 1 and 3, with no specific questions. The licensee discussed its proposed response to RAI No. 2 (ADAMS Accession No. ML110800418)¹ and requested the NRC staff to provide feedback to ensure that the mutual expectations on the scope and content of the intended information being provided are met. The NRC staff had no specific concerns with the information provided, but indicated that a detailed review will be performed after the information is submitted formally.


