The purpose of this modification is to increase the obligated amount by \$20,000.00 from \$2,615,000 to \$2,635,000. Accordingly, Paragraph (c) of Section B.3 entitled: "Consideration and Obligation - Cost plus fixed fee (JUN 1988) Alternate I (JUN 1991)" is revised to read as follows:  
"(c) The amount presently obligated with respect to this contract is \$2,635,000.00 of which \$2,424,200 represents the estimated reimbursable costs and \$210,800.00 represents the fixed fee."
