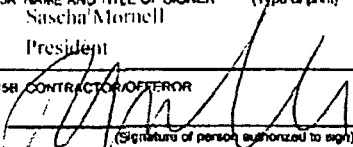
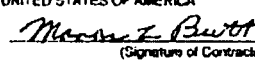

Reference Task Order OGC-001 under Contract NRC-10-07-414.

The purpose of this modification is to (1) decrease the task order ceiling, (2) revise the price schedule, and (3) add incremental funding, as follows:

1. Decrease the ceiling of Task Order OGC-001 by \$20,399.42, from \$264,043.59 to \$243,644.17.
2. An estimated price schedule showing revised Option Year Three, as well as the total task order ceiling in the amount of \$243,644.17, is attached.
3. Add incremental funding in the amount of \$18,252.00, thereby increasing the obligated amount from \$216,747.79 to \$234,999.79.
