As a result of realignment of resources and new priorities within the Nuclear Regulatory Commission (NRC), the Bellefonte Nuclear Plant (BLNP) Operating License (OL) review by NRC staff has been delayed until January 1980. It is our understanding that Argonne National Laboratory (ANL) will be performing part of the BLNP OL review to minimize delays in NRC licensing activities. The Tennessee Valley Authority (TVA) has therefore been asked by the NRC to forward a copy of the BLNP Final Safety Analysis Report (FSAR) to you. In accordance with that request, we are sending under separate cover an FSAR and all amendments to date; and you will be placed on our distribution list for all future amendments.
