To Whom It May Concern:

This is a notice to inform the Nuclear Regulatory Commission of a name change and change in ownership for Fort Wayne Cardiology in Fort Wayne, Indiana. The new name is Parkview Health System, Inc., d/b/a Fort Wayne Cardiology Corporation, which occurred on January 1, 2010. Following is the information required by NUREG 1556, Volume 2, Appendix G.


1. On December 31, 2009, Fort Wayne Cardiology, an Indiana Corporation, entered into a stock purchase agreement with Parkview Health System, Inc., by which the shareholders of Fort Wayne Cardiology transferred all right, title, and interest in the stock of Fort Wayne Cardiology to Parkview Health System, Inc.. Upon the stock of Fort Wayne Cardiology being owned by Parkview Health System, Inc. Parkview Health System, Inc., assumed operations for all Fort Wayne Cardiology services. As a result of all of the above, Fort Wayne Cardiology operates under the same license number as it has previously had, but is owned and operated by Parkview health System, Inc.
2. There will be no changes in personnel or duties that relate to the current licensed program
3. There will be no changes in the organization of the nuclear medicine department, the equipment, or the procedures that relate to the licensed program. The facility and location will relocate in the future and, once the new location and layout of the facility have been determined, the NRC will be notified.
4. The status of the surveillance program (surveys, wipe tests, quality control) at the present time is ongoing. The program is audited quarterly by a physics consulting group and all paperwork, procedures, etc. is in compliance.
5. All records concerning the safe and effective decommissioning of the facility will be transferred to the transferee. These records will include documentation of surveys of ambient radiation levels and fixed and/or removable contamination,

including methods and sensitivity.

6. The transferee will abide by all constraints, conditions, requirements and commitments of the transferor.
