On May 15, 1979, R. W. Wright, NRC-OIE Region II, was informed that the subject nonconformance was determined to be reportable in accordance with 10 CFR 50.55(e). This was followed by our interim reports dated June 15 and August 8, 1979. After that time, related NCR's 1053 and 1054 were determined to be reportable in accordance with 10 CFR 50.55(e). Subsequently, we submitted our combined final report dated October 5, 1979, our supplemental report dated January 14, 1980, our revised final report dated February 6, 1980, and a copy of the laboratory report referenced in our revised final report as supplemental information on February 12, 1980. In response to OIE comments on the revised final report, enclosed is the additional laboratory data requested by telephone on May 11, 1980.
