SUBJECT: CALENDAR YEAR 2010 ANNUAL REPORT OF THE U.S. NUCLEAR
REGULATORY COMMISSION ENFORCEMENT PROGRAM

Enclosed is the 16th Annual Report of the U.S. Nuclear Regulatory Commission (NRC) Enforcement Program. The Office of Enforcement (OE) prepared this report in accordance with a Commission-approved recommendation from a 1995 Enforcement Program review.¹

The 2010 Annual Report contains information regarding enforcement activities that occurred during the 2010 calendar year. The report contains information about significant escalated enforcement actions, noteworthy program accomplishments, and ongoing activities that have had an impact on the agency's Enforcement Program. It also includes various supporting statistical tables and figures. The appendices to this report summarize cases involving publically available escalated enforcement actions.

This report serves as an important agency communication tool for both external and internal stakeholders to ensure that the enforcement program is both understood and acknowledged as an integral, valuable component of the agency's regulatory programs. I intend to place this report in the NRC's Public Document Room, as well as in the Enforcement Documents Collection on the Electronic Reading Room Web page of the NRC's public Web site. Therefore, OE has not included sensitive security-related information, Safeguards Information, or Classified Information. OE will forward a separate report containing summaries of the security-related enforcement actions, which are not publicly available.
