The purpose of this modification is to de-obligate funds in the amount of \$20,526.51, which decreases the task order obligated and ceiling amounts from \$106,235.89 to 85,709.38.

Page 2, paragraphs 2 and 3 of the basic Task order 6 are hereby deleted in their entirety and replaced with the following:

Task Order No. 06 shall be in effect from August 21, 2008 through August 20, 2010, with a cost ceiling of \$85,709.38. The amount of [REDACTED] represents the estimated reimbursable costs, and the amount of [REDACTED] represents fixed fee.

The amount obligated by the Government with respect to this task order is \$85,709.38, of which \$81,627.99 represents the estimated reimbursable costs, and the amount of \$4,081.39 represents the fixed fee.
