On July 14, 2010, and November 18, 2010, AREVA NP submitted Supplement 2 and Supplement 3 responses to RAI 362 to revise the response schedule. The responses to the 5 remaining questions in RAI 362 are dependent upon the results of ongoing re-evaluations of GSI-191 source term, sump strainer design and testing. A revised schedule for providing technically correct and complete responses to the remaining questions in RAI 362 was developed based on these ongoing activities.

The 5 remaining questions include evaluations of the in-vessel, downstream effects of debris bypassing sump strainers. The schedule for responding to the remaining RAI 191 questions is revised and is provided below.
