Dear Sir or Madam:

In Reference 1, Entergy Operations, Inc. (Entergy) submitted a combined License Application (COLA) to construct and operate a new nuclear plant at the Grand Gulf Nuclear Station (GGNS) site near Port Gibson, Mississippi. The letter accompanying the license application requested that Nuclear Regulatory Commission (NRC) invoices for COLA reviews be addressed to NuStart Energy Development, LLC (NuStart) pursuant to agreements between the applicant and NuStart.

In Reference 2, Entergy submitted a COLA to construct and operate a new nuclear plant at the River Bend Station (RBS) site near St. Francisville, Louisiana. The letter accompanying the license application identified the point of contact for correspondence and invoicing as Mr. Jerry Burford, the Entergy RBS COLA project manager.

In Reference 3, Entergy requested that the NRC suspend review of the Grand Gulf Unit 3 (GG-3) and RBS Unit 3 (RBS-3) COLAs until further notice.


