The purpose of this correspondence is to communicate the intent to execute an Asset Purchase Agreement, whereby substantially all of the assets and liabilities of White County Memorial Hospital (WCMH), a component unit of White County, Indiana, will be acquired by Indiana University Health White Memorial Hospital Inc (IUH WMH). Clarian Health Partners, Inc. is the sole corporate member of IUH WMH. The closing date of the transaction will be the last business day of the month following the month in which certain regulatory approvals are received. This date is expected to occur on July 1, 2011.

As the new licensee, IUH WMH requests the NRC'S written consent to transfer control of NRC License # 13-20352-01. Pursuant to NUREG-1556, Vol. 15, please find the required information below to grant the required consent.



2. There are no changes in personnel controlling the radioactive material. The current CEO, RSO and other authorized users for this license will be the same as currently identified on the license and license applications on file.
3. There will be no changes in the organization, location, facilities, equipment or procedures that relate the radiation program at IUH WMH, except for the asset purchase and associated name change described in the introduction of this notification.
4. There will be no changes in the current surveillance program (survey wipe tests, quality control) at the time or as a result of this transfer.
5. The hospital can confirm that all records containing the safe and effective decommissioning of the facility will be transferred to the transferee as appropriate. All records are current and will be maintained by the new entity, IUH WMH.
6. IUH WMH can confirm its intent to abide by all constraints, conditions, requirements, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.
