Dear Mr. Weyers:

This is in reference to application dated February 1, 2011 requesting Nuclear Regulatory Commission License 25-29423-01. In order to continue our review, we need the following information:

1. Please provide a quantity per source and a maximum possession limit for the portable gauges you are requesting. The quantity per source will depend on the allowable amounts in the sealed source and device registry. The maximum possession limit should be commensurate to the total gauges you intend to purchase. Please note that you may request a higher maximum possession limit to account for future gauge purchases. For example, you can request 8 mCi per source for Cs-137 with a maximum possession limit of 24 mCi, and 40 mCi per source for Am-241 with a maximum possession limit of 120 mCi. This would allow for you to possess up to 3 gauges.
2. Please confirm you will implement and maintain the "Operating, Emergency and Security procedures" according to the errata to Appendix H of NUREG-1556 Program Specific Guidance About Portable Gauge Licenses, Volume 1, Revision 1. The errata to Appendix H is attached.

We will continue our review upon receipt of this information. Please reply to my attention at the Region IV Office and refer to Mail Control No. 574479. Please respond to this e-mail by April 22, 2011. You may reply via e-mail using a PDF format or by fax to 817-860-8263. If we do not receive a reply by the due date, we will assume that you do not wish to pursue your application.

Please do not hesitate to contact me if you need further clarification.

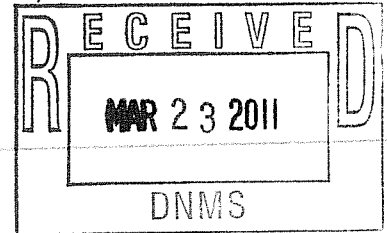

Per our conversation and confirmation with Troxler, Nelcon confirms our quantity limits in item #1 below to be 8 mCi per source for Cs-137 with a maximum possession limit of 16 mCi and 40 mCi per source for Am-241 with a maximum possession limit of 80 mCi. This would allow the use of two machines for our company.
