Pre-licensing Public Meeting with Southern California Edison Company (SCE)

On March 24, 2011, a public meeting was held between representatives of SCE, Excel Corporation, and staff to discuss the licensee's plans to submit a comprehensive license amendment to upgrade to the latest revision of the Combustion Engineering Improved Standard Technical Specifications for San Onofre Nuclear Generating Station, Units 2 and 3. This was the second publicly-noticed pre-licensing meeting on this subject.

Pre-Licensing Public Meeting with Arizona Public Service Company (APS)

On March 29, 2011, a public meeting was held between representatives of APS and staff regarding the licensee's plans to submit an amendment request to revise Technical Specification 3.7.4, "Atmospheric Dump Valves," for Palo Verde Nuclear Generating Station, Units 1, 2, and 3.

Public Meeting on Watts Bar, Unit 2, Final Safety Analysis Report Submittals

On March 29, 2011, a public meeting was held between representatives of the Tennessee Valley Authority and staff to discuss Watts Bar, Unit 2, Fire Protection Report submittals and responses to requests for additional information.

Issuance of the Hope Creek Generating Station and Salem Nuclear Generating Station Generic Environmental Impact Statement (SEIS), Supplement 45, Final Report

On March 30, 2011, the staff issued Supplement 45 to NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants Regarding Hope Creek Generating Station and Salem Nuclear Generating Station, Units 1 and 2, Final Report." This SEIS includes the staff's analysis that considers and weighs the environmental impacts of the proposed action, the environmental impacts of alternatives to the proposed action, and mitigation measures available for reducing or avoiding adverse impacts. It also includes the staff's recommendation regarding the proposed action: that the adverse environmental impacts of license renewal for Hope Creek Generating Station and Salem Nuclear Generating Station, Units 1 and 2, are not great enough to deny the option of license renewal for energy-planning decision-makers.

Issuance of the Safety Evaluation Report (SER) Related to the License Renewal of the Salem Nuclear Generating Station

On March 31, 2011, the staff issued the SER related to the Salem Nuclear Generating Station, Units 1 and 2, license renewal application. By letter dated August 18, 2009, PSEG Nuclear, LLC, submitted the license renewal application to the staff, requesting the extension of the operating licenses for an additional 20 years beyond the current 40-year terms. The staff performed its review of the application in accordance with 10 CFR, Part 54, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants." The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards on May 12, 2011, to discuss the SER.

Pre-licensing Public Meeting with Pacific Gas and Electric Company (PG&E)

On March 31, 2011, a public meeting was held between representatives of PG&E and staff to discuss the licensee's plans to submit a license amendment to incorporate management of new geotechnical seismic information into its design and licensing basis for Diablo Canyon Power Plant, Units 1 and 2. This was the third publicly-noticed pre-licensing meeting regarding this matter. The meeting was webcast to promote and enhance stakeholder engagement.

Public Meeting on Virgil C. Summer Transition to National Fire Protection Association (NFPA) 805

On March 31, 2011, a public meeting was held between representatives of the South Carolina Electric and Gas Company and staff to discuss the transition to NFPA Standard 805 for the Virgil C. Summer Nuclear Station, Unit 1.

Meeting with EnergySolutions (ES)

On March 31, 2011, ES met with staff to discuss some of the conditions of the Certificate of Compliance 71-9204 issued on February 28, 2011, and present proposed responses to the Request for Supplemental Information (RSI) for the Model No. 8-120B package application. Staff provided clarifications pertaining to the RSIs for the Model 8-120B package application. ES will not be in a position to submit complete responses by the deadline of April 7, 2011, and the 8-120B review will be suspended at ES' request. ES will submit a revised application in the June timeframe.

Holtec HI-STORM Flood/Wind Addition

On March 28, 2011, a direct final rule entitled "List of Approved Spent Fuel Storage Casks: Holtec HI-STORM Flood/Wind Addition" was published in the *Federal Register* (76 FR 17019). The companion proposed rule was published at 76 FR 17037. The direct final rule amends Part 72 by adding the Holtec HI-STORM Flood/Wind cask system to the list of approved spent fuel storage casks in 10 CFR 72.214. This direct final rule allows the holders of power reactor operating licenses to store spent fuel in this approved cask system under a general license. The final rule is effective June 13, 2011, unless significant adverse comments are received by April 27, 2011.

Publication of Revision 1 of Regulatory Guide (RG) 1.44, "Control of the Processing and Use of Stainless Steel"

On April 1, 2011, the RES staff published revision 1 of RG 1.44, "Control of the Processing and Use of Stainless Steel." RG 1.44 describes methods that the NRC staff considers acceptable for implementing requirements about control of the application and processing of stainless steel to avoid severe sensitization that could lead to stress-corrosion cracking.
