Mary Jean,

Under both the Privacy Act and the Freedom of Information Act, I am requesting the January 6, 2011 letter sent from Mr. Daryl M. Shapiro, Counsel for Union Electric Company at Pillsbury, Winthrop Shaw Pittman, LLP, to the US NRC. The letter contains a response submitted by Union Electric to the NRC's Petition Review Board concerning my (Lawrence Criscione's) September 17, 2010 10CFR2.206 petition. Please provide me a copy of this letter. I believe Mohan Thadani of NRR has a copy of this letter. The letter is mentioned in ML110470066 (see attached).

I request that the January 6, 2011 letter be made publically available in ADAMS. If this cannot be done, please let me know when you have a copy of the letter and I will come by the FOIA desk to obtain it.

Also, mentioned in the letter is an "understanding" which Ameren Missouri has with the NRC regarding:

"that Mr. Criscione's official NRC duties and responsibilities will not involve any matters with respect to Callaway."

Under the Freedom of Information Act and the Privacy Act I request all correspondence between Ameren and the NRC, including correspondence sent via agents such as Daryl Shapiro, which are related to the "understanding" which Ameren and the NRC has or had regarding my official NRC duties. Since it might take a good deal of time and effort for the NRC to find and review all this correspondence, I would like this request to be treated as a separate request from my request above for the January 6, 2011 letter. That is, I would like the above request for the January 6, 2011 letter treated independently so as not to delay its release by including it in the other correspondence relating to the source and evolution of Ameren's and the NRC's "understanding" regarding my official government duties.
