Contract NRC-DR-10-08-367 is hereby modified as follows:

The purpose of this modification is to fully fund Option Period #3. Funding in the amount of \$3,101,806.50 is hereby obligated. Funds are increased by \$3,101,806.50 from \$17,491,814.50 to \$20,593,621.00. The contract ceiling, through Option Period #3, shall remain unchanged at \$20,593,621.00. The total contract ceiling shall remain unchanged at \$26,923,725.00.

All other terms and conditions shall remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
