This report is an updated performance review of the groundwater corrective action program for the Grants site. Included in each report copy is a CD containing an electronic PDF file version of the report.

HMC noted in the past that monitoring conditions on the site are subject to change and may require periodic judgment decisions relative to the ability to supply certain data to meet the Table 2 - Groundwater Monitoring Program (8-99) requirements, as modified by NRC License provisions. With respect to the well monitoring requirements outlined in Table 2, monitoring wells 446 and 492 were not sampled in 2010 as the wells are either obstructed or supply inadequate water for sampling. As recommended in our 2009 annual report letter submittal, we are recommending, via the pending Corrective Action Plan review, that these wells be replaced by an alternate well for monitoring in this area.
