Dear Mr. Regan:

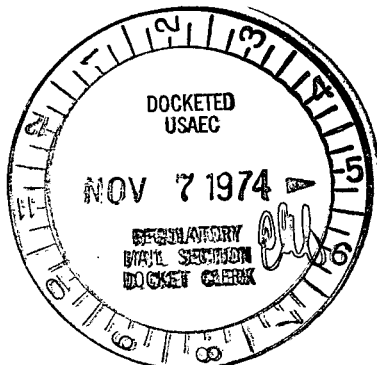
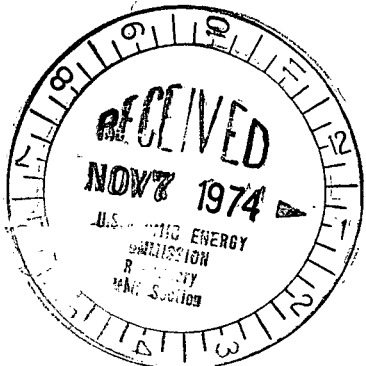
