Pursuant to the National Environmental Policy Act of 1969 and the United States Atomic Energy Commission's regulations in Appendix D to 10 CFR Part 50, notice is hereby given that the Final Environmental Statement prepared by the Commission's Directorate of Licensing related to the proposed issuance of construction permits for the Bellefonte Nuclear Plant, Units 1 and 2, to be constructed by Tennessee Valley Authority in Jackson County, Alabama is available for inspection by the public in the Commission's Public Document Room at 1717 H Street, N.W., Washington, D.C. and in the Scottsboro Public Library, 1002 South Broad Street, Scottsboro, Alabama 35768. The Final Environmental Statement is also being made available at the Alabama Development Office, State Office Building, Montgomery, Alabama 36104, and Top of Alabama Regional Council of Governments, P. O. Box 308, City Hall - 6th Floor, Huntsville, Alabama 35801.


The notice of availability of the Draft Environmental Statement for the Bellefonte Nuclear Plant, Units 1 and 2, and requests for comments from interested persons was published in the FEDERAL REGISTER on February 1, 1974 (39 F.R. 4127). The comments received from Federal,

State, local and interested members of the public have been included in an appendix to the Final Environmental Statement.
