1. **Section B.3, CONSIDERATION AND OBLIGATION – HYBRID CONTRACT**, delete in its entirety and replace with the following,

“a. The total price of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$6,026,712.03 which covers the base period and option periods. The contract may be incrementally funded with appropriated funds to the extent noted in Section B.1 PRICE/COST SCHEDULE.

b. The total price for the Option Year 1 period is \$1,171,746.70 of which \$1,161,081.70 is for the firm fixed price portion and \$10,665 is for the cost reimbursement portion.

c. The amount currently obligated by the Government with respect the Option Year 1 is \$336,000.00. The option year 1 is not fully funded.”

2. **Section B.5 STATEMENT OF WORK – Technical Assistance for Employee Health Services, subpart 3.5 Hours of Operation**, delete in its entirety and replace with the following,

“The NRC Employee Health Center shall be open Monday through Friday from 7:00 a.m. to 5:00 p.m. except Federal holidays or when the Government offices close because of inclement weather, potentially hazardous conditions, or other special circumstances.”
