Enclosed is Amendment No. 04 to your NRC Material License No. 13-32528-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**Please note that we removed Condition No. 12. B as it appeared on Amendment No. 03 in your NRC Material License. Due to an NRC policy change, you will not be able to change and name your Radiation Safety Officer (RSO) internally as Condition No. 12. B previously allowed. NRC must do that for you via the amendment process.**

**For future RSO changes please submit the name of the proposed RSO; his/her training and experience qualifications; a statement signed and dated by the proposed RSO that s/he accepts the position as RSO and that s/he understands the duties and responsibilities associated with the RSO position.**

**We also removed Condition No. Conditions No. 24 as it appeared in Amendment No. 03 of your material license. Condition No. 24 was redundant due to already having possession limits on you license**

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability. 
