3) Transportation and Route Schedule

The vessel sails from Walvis Bay, Namibia on January 16, 2011. The ocean transportation from Walvis Bay, Namibia to Montreal, Quebec, Canada will be the responsibility of CSA Line. The vessel will unload at Montreal, Quebec, Canada on or about February 05, 2011. The container will enter the USA by road at Champlain, NY between approx. February 10-14, 2010 and continue on to Metropolis, IL. The inland transportation from Montreal, PQ to Metropolis, IL will be the responsibility of RSB Logistic Services Inc.
