2) Physical Description

This shipment will consist of 8 cylinders of Uranium Hexafluoride (UF₆) in sealed overpacks. The cylinders are 30B cylinders containing 12,320 kgs Uranium enriched to less than 5% weight of U-235.

3) Transportation and Route Schedule

The ocean transportation from Antwerp, Belgium to Baltimore, MD will be the responsibility of Atlantic Container Line. The inland transportation from Baltimore, MD to Westinghouse/Columbia, SC will be the responsibility of RSB LOGISTIC SERVICES, INC.
