Alliance Solution Group (ASG), Inc. is seeking access to records under the Freedom of Information Act and the Privacy Act. ASG is a small, service-disabled, veteran-owned business that offers homeland security solutions to federal, state, and local government agencies as well as private industry.

ASG is currently under contract by the USAF Air Mobility Command to perform Toxic Industrial Chemical (TIC) and Toxic Industrial Materials (TIM) vulnerability assessment at Little Rock Air Force Base, Pulaski County, in Arkansas. If any information is to be withheld, please notify me and ASG will request the USAF file a separate request. In order to complete the assessment, we need to identify and quantify any information on radioactive materials stored/used within 20 miles of the base. We are requesting information on the companies or businesses that currently have radioactive material licenses/permits within the cities of Conway, Enola, Holland, Mayflower, Mount Vernon, Vilonia, Austin, Cabot, Lonoke, Beebe, Cammack Village, Jacksonville, Little Rock, Maumelle, North Little Rock, Sherwood (Faulkner, Lonoke, White, Pulaski Counties). If possible, please provide a copy of the license/permit indicating the specific isotope and maximum activity authorized for each item. This information can be provided electronically(CD) if available.

ASG is willing to pay the applicable fees, if any, associated with processing our FOIA and PA request. If you need any additional information, please contact me at 757-303-6669. Thank you.
