Question from Environmental Technical Support Branch (RENV)

NRC RAI Number: 9.3.1-1 (RAI 5481 Rev. 2)

The staff requests the following information to assist in describing the cultural environment for the St. Lucie alternative site. Provide any cultural resources investigation information and reports related to the recent discovery near Old Blind Creek, and the shell midden where 14 Native American burials were discovered. As described during the alternative sites visit on July 13, 2010, this information resulted from archaeologist investigations for a possible wind turbine site. There may have been other sites that were discovered during this investigation that contained artifacts such as pottery. Because this information pertains to work performed at the existing St. Lucie plant site, it should be available in FPL files.

FPL RESPONSE:

Archaeological investigations conducted for a potential wind turbine site comprise the most recent cultural resource surveys conducted on the St. Lucie plant site. These investigations were conducted in January and February 2008 at six separate parcels, which are collectively called the FPL Wind Turbine Parcels. The assessment and results are documented in the report titled A *Phase I Cultural Resource Survey and Assessment of Florida Power & Light Corporation Wind Turbine Parcels, St. Lucie County, Florida* (June 2008). [A copy of this report is enclosed. Information regarding the potential location of historic properties has been redacted from this report, as such information is requested to be withheld under the National Historic Preservation Act, 16 U.S.C. 470w-3(b) and 36 CFR 800.11(c).] The survey identified one previously unrecorded archaeological site (8SL3045), however, this site is not located near Blind Creek; it is referred to as a prehistoric midden site and not a Native American burial mound (refer to Consultant Summary page 1 of the enclosed report).

Numerous cultural resource literature reviews and surveys have been conducted along Blind Creek, north of the St. Lucie plant site, since the late 1960s. The two most recent of these studies were conducted in 2007 and 2008 by the Archaeological and Historic Conservancy, Inc. (AHC) for the St. Lucie County Mosquito Control District. These studies include the following:
