Thank you for the copy of the Final Environmental Impact Statement for the Bellefonte Nuclear Plant Units 1 and 2. The document contains information which will certainly be considered in siting an airport to serve the Scottsboro, Alabama, community.

We have received a preliminary site investigation report from the consultant which identifies several possible locations for an airport. It is our understanding that TVA is presently evaluating each site from a safety standpoint and we anticipate receiving the results of that evaluation in the near future.
