Submitted herewith are 200 copies of TVA's response to the request for additional information transmitted by William H. Regan, Environmental Projects Branch 4, Directorate of Licensing, in his letter dated September 13, 1973. An additional 100 copies are retained for future use, as requested. Responses to comments 15, 20, 26, 49, and 76 will be delayed as indicated by our September 25, 1973, letter to Mr. Regan. In addition, we were not able to complete our responses to comments 47, 50, 51, 53, 54, and 55 in time to be included with this letter. We are attempting to expedite these responses as much as possible and will advise you within the next few days with respect to them.

Please correct our July 12, 1973, letter sending Amendment 1 to the TVA applications for units 1 and 2 of the Bellefonte Nuclear Plant to indicate that the separate bound document provides responses to AEC's comments on the Bellefonte draft environmental statement. The separate bound document is not to be considered a supplement to the draft environmental statement.


