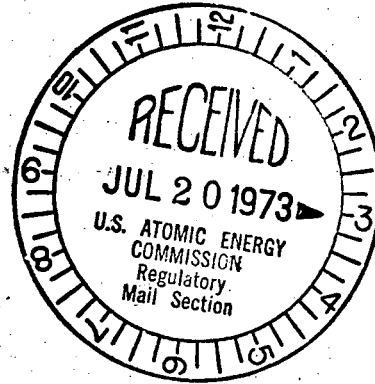

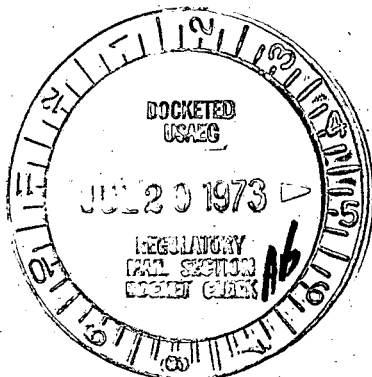
Submitted herewith is Amendment 1 to the TVA applications for units 1 and 2 of the Bellefonte Nuclear Plant. The amendment consists of the following:


