Dear Mr. Seeber:

As a result of meetings with representatives of Tennessee Valley Authority and AEC on October 3, 1972, and April 18, 1973, it was agreed that the following procedure will be followed by the Atomic Energy Commission in the preparation of its Environmental Statements under the National Environmental Policy Act of 1969. This procedure will supercede the procedure stated in our letter of June 30, 1971, from H. L. Price, Director of Regulation.

1. TVA will submit its environmental statement for each future facility concurrent with its application.
2. The AEC will consider this TVA environmental statement to be the Environmental Report required of all applicants and will judge its adequacy in accordance with 10 CFR Part 50, Appendix D, and with Regulatory Guide 4.2.
3. The AEC will independently prepare its Environmental Statement.

Further, in the future we do not intend to respond as a commenting Federal Agency on the draft environmental statements prepared by TVA. Such comments would be premature in view of our intent to conduct an independent evaluation of all environmental aspects of the proposed plant pursuant to preparation of the AEC Environmental Statement.


