Initial report of the subject deficiency was made to NRC-IE, Region II, on September 16, 1975, and was followed by our interim reports from J. E. Gilleland to Donald F. Knuth dated October 16, 1975, December 5, 1975 and February 9, 1976. This is submitted as a fourth interim report. We expect to submit our next written report by June 11, 1976.

The metallurgical investigations being conducted by TVA and the post-tensioning contractor are incomplete at this time. Documentation of material furnished by the post-tensioning contractor is available; however, we plan to supply this information as a part of the final report.
